Sub:- Inspection of private hospitals, approved under Rajasthan Civil Service (Medical Attendance) Rules, 2013 (list appended)

State Government empanels private hospitals under Rajasthan Civil Service (Medical Attendance) Rules, 2013 on fulfilling prescribed norms/parameters for providing medical facilities to State employees (appointed before 01-01-2004) and civil pensioners.

As per the Memorandum of Agreement (MOA), approved hospitals are bound by following clauses:-

- "Clause of Rates:- The second party (approved hospital) will display properly at the reception, Laboratory and Web site the rates of various Diagnostic tests, Operation Charges, Cost of Implants, Dialysis and Blood Bank Charges and Accommodation Charges along with the discounts offered to State Government employees."
- "Inspection by the Committee:- Representatives appointed by the Chairperson of the Health Benefits Empowered Committee of Government of Rajasthan or Divisional Commissioners/Collectors can inspect the hospital during M.O.A. period to ascertain that the parameters of approval are being maintained properly by the Hospital."

It is pertinent to mention here that the State Government vide Finance Department order no. f. 6 (2) FD/Rules / 2013 Pt. III dated 27-06-2015 (copy enclosed) has decided to adopt the rates of CGHS, Jaipur as may be amended from time to time, as maximum chargeable rates for various treatments, investigations and implants etc. which can be charged by the approved hospitals for treatment of Government servants appointed before 01-01-2004 and State pensioners.

It has come to knowledge that few approved hospitals do not display properly the status of their empanelment under RCS (MA) Rules, 2013 for treatment of State employees and pensioners, and clause of rates which are applicable for such treatment.

In this regard all District Collectors are requested to constitute a committee under the chairmanship of an officer not below the rank of Sub-Divisional Magistrate for random inspection of approved hospitals to ensure compliance of above mentioned terms and conditions of Memorandum of Agreement by the approved hospitals.
